## What is Credentialing?

- Process by which the Service Center trains and grants security access to HRS end-users
- "Credentials" will be granted after completing necessary training and demonstrating competence in defined objectives
  - These will mostly be demonstration "tests"
- Curriculum developed based on all HRS modules
  - Each institutional end-user will be assigned a learning path(s) based on their security roles

Reconciliation	BERT
<ul> <li>Reconcile/Audit benefit plans to identify exceptions</li> </ul>	Complete holistic analysis
Create Wisclt's for exceptions	<ul> <li>Coordinate with SC Benefits correction of HRS data when applicable</li> </ul>
<ul> <li>Process payments to providers</li> </ul>	<ul> <li>Create Paylines for collections/ refunds</li> </ul>
	<ul> <li>Communicate to campus Benefit Administrators results of holistic review and pending action</li> </ul>

## Internal Reconciliation Requests

#### **Campus Initiates Request**

- Campus contacts Service Center Affinity Group (AGs)
- AGs create Wisclt if one has not already been created through the Reconciliation Audit process
- AGs make HRS updates and forward WiscIT to BERT if reconciliation is needed
- BERT completes holistic review and communicates directly with campus the results of analysis within 2 business days.
- Additional action is taken when necessary such as:
  - Paylines
  - Job Record Updates
  - Benefit Record Updates

## Monthly Pay Week Processing

#### Thank you for your feedback!

Based on your feedback this looks like a viable option. Discussions are taking place and official communication on changes is forthcoming.

For optimal processing of the unclassified payroll, we are looking at reducing the number of jobs being run during the morning of final calc days. (One day per month - Normally on a Thursday morning)

Proposal for changes to processing on unclassified final calc days

- 8am and 10am biweekly & noon monthly absence calc runs will be condensed to 9am biweekly and 11am monthly absence calcs
- Time and Labor 9am and 11am jobs will not run on the mornings of unclassified payroll final calc days. Should have minimal impact since these are biweekly processes. They will still run at 4am, 1pm, 3pm and during nightly batch.
