#### PAY PLAN IMPLEMENTATION

- 12C Confirm is underway
- In Process
  - MIL & OSH Pay Plan with Chancellor's Discretionary Award letters
  - Retiree letters
- Pay Plan Check Ins with institutions
  - Updates from institutions
  - Continue to send in tickets
- Payroll Retro
  - Job adjustments made after Monday, 1/1/24 will load and pay on the 1A
  - In calculated status on Retro Pay Calculation Results



# RETRO PAYMENT FUNDING - REMINDER

Here is how funding will work with the retro payment. This is a reminder on how retro funding has always been applied.

- Employees in the <u>same position</u> as they were in on the effective date of pay plan (7/2 or AY start date) retro will apply the funding that is active as of the current (12C) payroll regardless of whether there have been any changes in funding over that retroactive period.
- Employees who have had a <u>change in department</u> since the effective date of pay plan (7/2 or AY start date) retro will apply the funding that was last in effect for each position held over the retroactive period.

Any funding that is invalid, including closed projects, will be replaced with PRDFLT as part of the Finance post confirm processing.
