2024 IOWA W-4 CHANGES

- New for 2024: IA no longer recognizes number of allowances.
 - Total allowances are now recognized as a dollar amount \$40 per eligible allowance
- Withholding based on the 2024 W-4 will begin on the 3A Payroll.
 - Email communication will be sent to all employees currently reporting to Iowa to complete a new W-4 form.
 - Employees should file an updated W-4 form no later than 03/13/24.
- For employees who did not file an updated W-4 in time; a flat \$40 Total Allowance will be used to calculate withholding beginning on the 3A, until a new form is received.



2024 MONTANA W-4 CHANGES

- New for 2024:
 - MT no longer recognizes number of allowances.
 - New Tax Status field on the MW-4 mimics federal tax status option.
 - Reduced Withholding field dollar amount entered in this field will be the amount withheld. Standard withholding calculation will not be used.
 - This will reduce the amount of tax withheld and may result in a balance due when employees file their tax returns.
- Email communication has been sent to all employees who currently report to Montana to complete a new MW-4 form.

FORM 1042-S RECONCILIATION

- The 2023 Form 1042-S Tax Reconciliation is complete.
- Form 1042-S is now available electronically via Glacier for those who were eligible for and elected this option.
 - Some individuals were not able to elect electronic distribution, some reasons for this are:
 - Not having a Glacier account
 - Having payments made from Accounts Payable
 - Those not given the electronic option will have paper forms printed and mailed out tomorrow, 3/1/24.
- Glacier Tax Prep is now available for all Nonresident Aliens as of 2/28/2024.
 - An email communication was sent to all nonresident aliens in Glacier as of 12/31/2023 on the evening of 2/27/2024.
