A & H Basis Raise to Campus Minimum Output Files sent to Institutions	Friday, June 28, 2024
FLSA Updates – move to non-exempt, pay rate adjustment, and/or threshold exemption updates	Monday, July 1 – Tuesday, July 2, 2024
FLSA Letters Distributed & ePfile upload– move to non-exempt; pay rate adjustment	Monday, July 1 – Tuesday, July 2, 2024



### DATA CLEANUP

- Position of Trust
  - Initial cleanup will focus on CP, CJ, FA, AS and LI empl classes
- Auditing employees in those empl classes who are missing a person assignment checklist
  - Employees without a checklist will not have a Position of Trust selection in HRS
- UWSS will create person assignment checklist for all employees missing one, using POTN (Position of Trust – No)
  - List will be sent to campuses to review these employees to determine if any of them should be updated to a different POT selection (POTY, POT4, POT2)

### NEW PAID PARENTAL LEAVE POLICY

- New policy is effective July 1, 2024: APPROVED
- Provides up to 6 weeks (240 hours) of paid time off following a qualifying birth or adoption
  - Allows for time to bond with their new child
  - Adjust to new family situation
  - Balance personal obligations resulting from the birth or adoptive event
- Hours are prorated by FTE at time of the qualifying event
